RENTAL LIABILITY WAIVER AND SAFETY PROTOCOL

Liability Waiver

Participant also understands and agrees that by registering, they are giving up their right (or the minor for whom they register) to make any claim against The Salvation Army, its agents, employees, and volunteers, including the right to sue them, for bodily injury, property damage, contraction of a communicable disease and/or contraction of a viral or bacterial infection of any kind and/or any other loss that they might suffer while using The Salvation Army San Diego Citadel facilities and/or services, except as limited by law.
